Unless otherwise stated, the control results passed for this order.

A result of P (for Pass) corresponds to a median fluorescence index (MFI) at or above the Anti-Ig assay cutoff, typically ≥ 7000 . An Anti-Ig assay result of F (for Fail), assigned if the MFI is below the cutoff, might occur because the sample was received too dilute, was collected from an immunocompromised host or was from a species other than the one for which the MFIA is intended. If a sample fails the Anti-Ig MFIA, then negative and borderline results in MFIA for microbial antibodies are considered I (for inconclusive).
